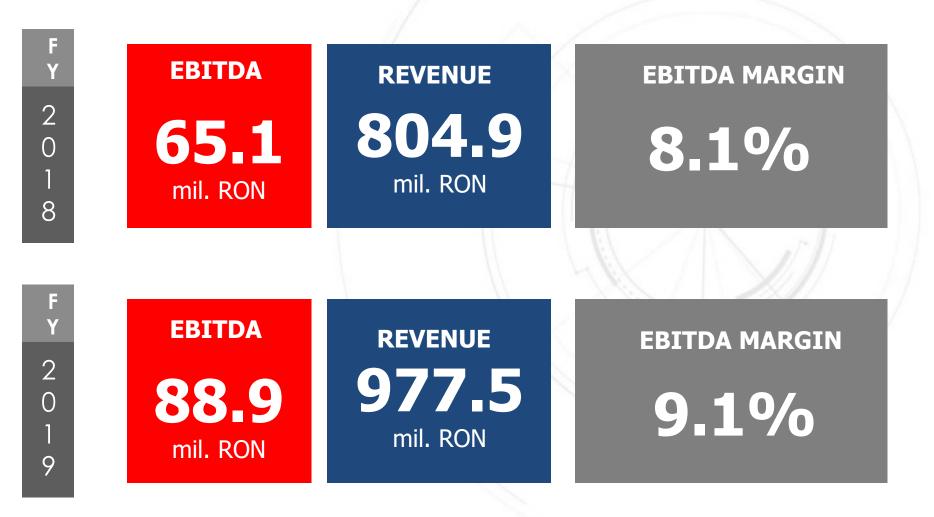

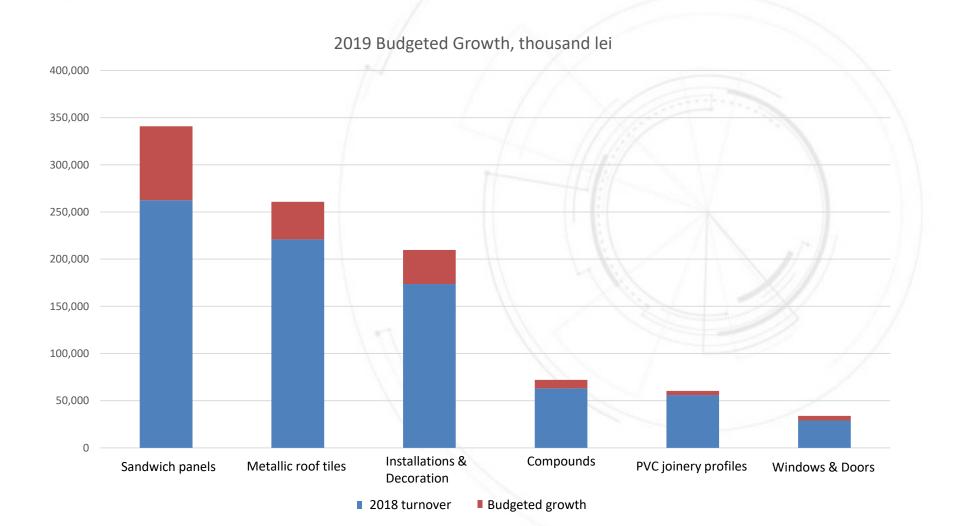

ASSUMPTIONS AND GROWTH FACTORS





- Market share increases:
 - Potential to increase TeraSteel market share in Central and Eastern Europe
 - Compound and joinery profiles areas have a favourable market landscape
 - Wetterbest and TeraGlass act on markets with many players, most smaller players
 - Expand production capacities through projects co-financed through State grants
- Exit the stagnation area of the infrastructure works:
 - Infrastructure works have exceeded the design, bidding and (eventually) the phases of appeal. There are currently ongoing execution contracts.
- Economic correction does not appear for 2019
 - The budget was based on the premise that there will be no major market corrections in 2019
 - The diversity of the group's business, both as product range and geographically, can accommodate a minimal correction and deliver the budgeted figures

2019 STRATEGY SANDWICH PANELS



TeraSteel Sandwich Panels (Romania & Serbia)

- In 2019 we target sales of 340 million RON (2018: 262 million RON)
- We will increase the sales of mineral wool panels manufactured in Serbian factory
- We will further increase our market share in Central and Eastern Europe offering a complete portfolio of products for non-residential buildings: sandwich panels with polyurethane foam and mineral wool, metallic structure and folded metallic tile
- We will develop our value-added products and "turn-key" concepts



2019 STRATEGY ROOF SYSTEMS



Wetterbest – Roof sysyems

We aim an 18% turnover increase in comparison to 2018

- Production capacity expansion will facilitate the increase in market share
- The new production facility in Baicoi (Prahova) will allow logistics and production flow optimisation, which will lead to increased profitability
- The investment will be co-financed through State grant: the investment project requires 18,2 million RON, and the State grant financing represents 8,9 million RON
- We look to develop business partnerships with small producers and also steel trading



2019 STRATEGY INSTALLATIONS



TeraPlast – Installations

(sewerage, water and gas)

Objectives:

- PE and PP sewerage systems development: coextruded and multilayer pipes for inner sewerage, including soundproofed pipes (investments through State grant)
- Increased capacity for outer sewerage systems: PP pipes and injected components (e.g. manholes)
- As market leader in the field of outer sewage, we also aim to increase the sales from related products, e.g. drilling pipes and injected products
- Product range development investments through State grant project



2019 STRATEGY COMPOUNDS



TeraPlast – Compounds

We will continue to increase the turnover and to maintain the EBITDA margin relying on the deferentiators that have made us the market leader in Romania: the ability to develop recipes that correspond to the technical specifications demanded by our clients at competitive prices

Objectives:

- Launching new products (HFFR compounds)
- Exploit current opportunities on export markets
- Recycled materials sale to third parties



2019 STRATEGY PVC PROFILES



TeraPlast – PVC Profiles

- Increase the use of recycled PVC, which is produced within the group
- Launch of the profiles' second generation: high gloss, new gaskets and for the main profiles- the layer technology
- Increase the distribution network
- Sales increase in Hungary via TRP Hungaria kft



2019 STRATEGY RECYCLING



TeraPlast – Recycling

In the last 6 months (September 2018 - February 2019), on average we produced 600 tonnes / month of recycled PVC, which is used internally

- functioning as an independent business
- extension of the post-industrial waste collection network in Romania and CEE
- sales to third parties without having just TRP as unique customer

TeraGlass – Windows & Doors

We will double the production capacity with an EUR 3.8 million investment, 50% financed through State grant





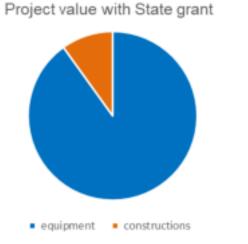
TERAPLAST SA INVESTEMENT PLAN

INVESTMENT PLAN

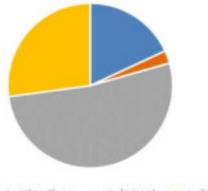


For 2019, the company has an investment program worth 69 million RON, of which:

- > 24 million RON for financial investments
- > 16 million RON for equipment, maintenance and construction
